Performer Contract Agreement

This Performer Contract Agreement ("Agreement") is made and entered into as of [Date] by and between:

1. Engagement of Services

The Company hereby engages the Performer to provide performance services for the event(s) described below, and the Performer hereby accepts such engagement.

 - If the event is scheduled more than one year in advance, either party may cancel this Agreement with written notice provided at least 90 days prior to the event date.

- Cancellations made within 14 days of the event date may result in forfeiture of the Performer's fee (if applicable).
- If the Company cancels the event within 14 days of the event date, the Performer may be entitled to the agreed-upon fee.

5. Performer's Obligations

- The Performer agrees to provide a professional performance and to arrive at the event location on time.
- The Performer agrees to conduct themselves in a professional manner and comply with all rules and regulations set by the event venue.
- The Performer will be responsible for their own transportation to and from the event unless otherwise agreed upon.
- The Performer must not engage in rude, abusive, or aggressive behavior.
 - Such conduct may result in immediate termination of this Agreement on the day of the gig or in the lead-up to it.
- Any false or harmful allegations made by the Performer will be investigated and may result in termination of this Agreement.

6. Company's Obligations

- The Company agrees to provide the agreed-upon compensation (if applicable) and any other provisions as outlined in this Agreement.
- The Company agrees to provide a safe and suitable performance environment.

7. Liability

The Performer agrees to indemnify and hold harmless the Company from any claims, losses, or damages arising out of or in connection with the Performer's services under this Agreement.

8. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the United Kingdom.

9. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements, understandings, and negotiations, whether written or oral, between the parties with respect to the subject matter hereof.

10. Amendments

No amendment or modification of this Agreement shall be valid or binding unless made in writing and signed by both parties.
